Addressing the social, ethical and participatory dimensions of nuclear R&D offers great opportunities for the development of trans-disciplinary project proposals in the nuclear field, and collaboration with partners from multiple disciplines that embrace a range of issues, dimensions and expertise. 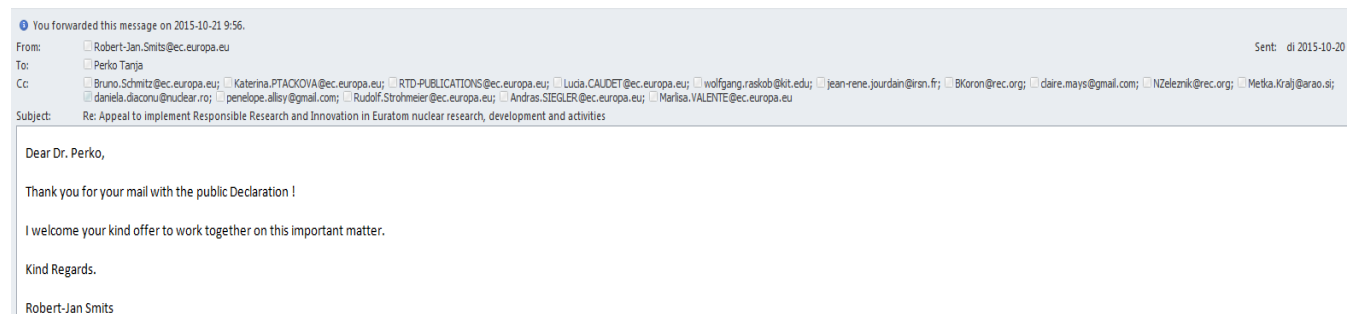

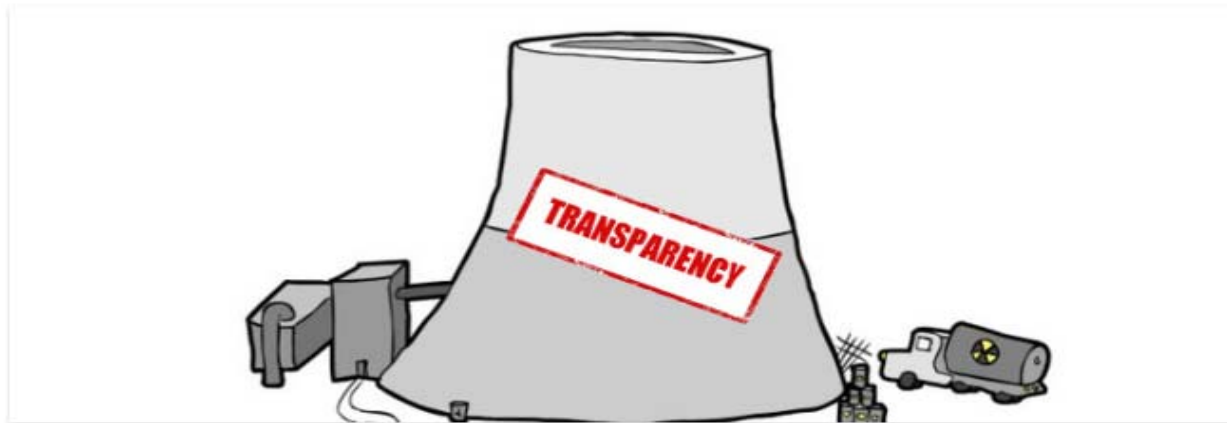

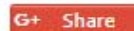
